For Vacancies in Commercial and Industrial Buildings

- The deadline for submitting applications is February 28 of the year following the taxation year to which the application relates (eg Feb 28 2015 for 2014 vacancy).
- Any person who knowingly makes a false or deceptive statement in this application is guilty of an offence and, upon conviction, is liable for a fine.
- Deliver this completed application to your local municipal office at: 4432 George St, Sydenham, On.
- To be eligible for a rebate, a building or portion of a building must satisfy the conditions described in Category 1 or Category 2 below.

 Category 1 - Buildings that are Entirely Vacant Buildings or structures that are in the commercial or industrial property classes are eligible property if; The entire building was unused for at least 90 consecutive days; and No portion of the building or structure was used at any time in the 90-day period. Category 2 - Buildings that are Partially Vacant A portion of a building that is in one of the commercial property classes (office buildings, shopping centres, etc.) are eligible property if, for at least 90 consecutive days, it was; Unused; and Clearly delineated or separated by physical barriers from the used portion of the building; and Clearly delineated or separated by physical barriers from the used portion of the building; and The portion of the building was: 	 Exclusions The following properties are not eligible for the rebate Seasonal Property A building, structure, or portion of a building that is used for Commercial or industrial active on a seasonal basis is not eligible property for the season they are closed. Leased Property A building, structure, or portion of building that is vacant but is leased to a tenant who is in possession of a leasehold interest is not eligible. Vacant Land Subclass A building, structure or a portion of building that is included in a vacant land subclass (e.g., new building that has never been occupied) is not eligible property.
 Capable of being leased or immediate occupation Not capable of being leased for immediate occupation because it was in need of or undergoing repairs or renovations or was under construction or Was unfit for occupation. A portion of a building that is in one of the industrial property classes (large industrial) will be eligible property if, for at least 90 consecutive, portion of the building was: Unused; and Clearly delineated or separated by physical barrier from the portion of the building that was used.
