## **WOOD BURNING APPLIANCE APPLICATION CHECKLIST**

- 1) Completed Building Permit application form
- 2) Appliance documentation - Installation requirements of the appliance including clearances
- 3) Stove pipe and/or Chimney documentation
- 4) Floor plan including stove placement with clearances to combustible materials and floor protection
- 5) Carbon Monoxide and Smoke Detectors must be installed at the time of inspection
- 6) A Heat Recovery Ventilator (HRV) may be required
- 7) Copy of the deed or tax bill (proof of land ownership)
- 8) Setback Waiver Form

**NOTE:** An in-depth plans examination may reveal that further information may be required from the applicant to satisfy compliance with the Ontario Building Code or other applicable law.
