a. Canada Day Fireworks Update

- Loughborough district's grant was received and is pending approval.

b. Point Park Shoreline Restoration

- Stew Seabrook of Riggs Engineering presented to Council.
- Committee members discussed their concerns in regards to the costs involved.
- Council requests a motion from SFRC outlining the recommendation.
