BY-LAW 2001-04

A BY-LAW TO PROHIBIT THE DISCHARGE OF GUNS OR OTHER FIREARMS IN A PORTION OF THE LOUGHBOROUGH DISTRICT

WHEREAS Section 210 (36) of the Municipal Act, R. S. O. 1990. Chapter M. 45, as amended, authorizes councils of municipalities for the purpose of public safety to prohibit or regulate the discharge of guns or other firearms, air-guns, spring-guns, cross-bows or long-bows or any type thereof in the municipality or in any defined area thereof; and,

WHEREAS Section 320 of the Municipal Act provides that any person who contravenes any by-law passed under the authority of the Municipal Act is guilty of an offence; and,

WHEREAS it is necessary to regulate by prohibition the discharge of fire arms in portions of the village of Sydenham and the vicinity;

NOW THEREFORE THE CORPORATION OF THE TOWNSHIP OF SOUTH FRONTENAC, BY ITS COUNCIL, HEREBY ENACTS AS FOLLOWS.

- 1. The discharge of a firearm in that portion of the village of Sydenham and vicinity as defined in Schedule "A" attached hereto is prohibited.
- 2. Firearms are defined to include pistols, rifles, shotguns, air-guns, spring-guns, cross-bows and long bows.
- 3. The prohibition against the discharge of a firearm shall not apply to members of a properly constituted police force in the performance of their duties or to a farmer who discharges a firearm for the purpose of protecting livestock or crops from predators on property which the farmer owns or occupies.
- 4. With the written permission of Council the use of blank ammunition at a gun dog trial or demonstration may be permitted. With the written permission of Council archery competitions and training events may be permitted.
- 5. Every person who discharges a firearm in the area defined in Schedule "A" to this by-law is guilty of an offence and upon conviction shall be liable to a fine not exceeding \$5,000.00 (Five Thousand Dollars).
